

2023 TAX LISTING NOTICE

Listing Begins Tuesday, January 3rd
and Ends Tuesday, January 31st

TIME: MONDAY - FRIDAY • 8:00 AM - 5:00 PM

YOU ARE NO LONGER REQUIRED TO LIST FOR PROPERTY TAXES ANY VEHICLES WHICH ARE CURRENTLY LICENSED WITH THE NORTH CAROLINA DEPARTMENT OF MOTOR VEHICLES. THE PROPERTY TAX ON THESE VEHICLES WILL BE BILLED BY DMV AND MUST BE PAID AT THE TIME YOUR CURRENT REGISTRATION IS RENEWED OR APPLICATION IS MADE FOR A NEW REGISTRATION. HOWEVER, IF YOU OWN ANY PROPERTY LISTED BELOW, YOU MUST LIST:

WHAT TO LIST

1. Mobile homes, boats and motors, jet skis, aircraft (includes hot air balloons and gliders).
2. Motor vehicles: You must list UNLICENSED, IRP, APPORTIONED, PERMANENT OR 3 MONTH FARM TAGS including cars, trucks, motorcycles, camping trailers, motor homes, boat trailers, utility trailers, etc. Provide the name shown on the title, year, make, model, body style and complete Vehicle Identification Number (VIN). Without the VIN, we cannot accurately value the vehicle. Indicate the vehicle condition.
3. All farm equipment.
4. All business assets including machinery, equipment, computers, furniture, fixtures, expensed items, supplies, etc.
5. All improvements or changes to real estate.

PENALTY FOR FAILURE TO LIST SHALL BE 10 PERCENT OF TAX LEVIED AS REQUIRED BY SECTION G.S. 105-308 OF THE MACHINERY ACT.

SPECIAL NOTICE: Property owners 65 years of age and older, or totally and permanently disabled persons with a limited income may contact the office to see if they qualify for the homestead exemption or homestead circuit breaker deferment exemption, and request an application. Veterans that were honorably discharged and have a service-connected permanent and total disability need to contact the office for an application to receive the disabled veterans homestead exclusion.
