

## **Property Tax Relief Checklist**

## The following Checklist will help provide guidance on the documents needed to meet the requirements for the Property Tax Relief programs per N.C.G.S.

**New Applicants**: The *application* and income information are due to our office no later than June 1<sup>st</sup> of the current year.

**Audit Applicants:** The *questionnaire* and income information are due to our office no later than March 1<sup>th</sup> of the current year.

## Elderly/ Totally & Permanently Disabled Exclusion Requirements:

- First page of your individual Federal Income Tax Return for the previous calendar year.
  - a. Married applicants file separate returns must submit both Federal Income Tax returns for the previous year.
- Certificate of Disability (for applicants under 65 years of age as of January 1<sup>st</sup>)
- \_\_\_\_\_ Copy of W-2
- \_\_\_\_\_ Copy of 1099 forms for Interest (Taxable & Tax Exempt)
- \_\_\_\_\_ Copy of 1099 forms for Dividends
- \_\_\_\_\_ Copy of 1099 forms for Capital Gains
- **Copy** of 1099 forms for all IRA distributions
- \_\_\_\_\_ Copy of 1099 forms for all Pension and Annuities
- \_\_\_\_\_ Copy of 1099 forms for Social Security Benefits
- **Copy** of any of financial institution Statements
- \_\_\_\_\_ Report State and/or Federal income tax refunds received in prior year
- **Completed and signed** application or questionnaire

## **Circuit Breaker Deferment Requirement:**

- Certificate of Disability (for applicants under 65 years of age as of January 1<sup>st</sup>)
- **First** page of your individual Federal Income Tax Return for the previous calendar year.
  - a. Married applicants file separate returns must submit both Federal Income Tax returns for the previous year.

- \_\_\_\_\_ Copy of 1099 forms for Interest (Taxable & Tax Exempt)
- \_\_\_\_\_ Copy of 1099 forms for Dividends
- \_\_\_\_\_ Copy of 1099 forms for Capital Gains
- \_\_\_\_\_ Copy of 1099 forms for all IRA distributions
- \_\_\_\_\_ Copy of 1099 forms for all Pension and Annuities
- \_\_\_\_\_ Copy of 1099 forms for Social Security Benefits
- \_\_\_\_\_ Copy of any of financial institution Statements
- \_\_\_\_\_ Report State and/or Federal income tax refunds received in prior year
- \_\_\_\_\_ Completed and signed application

**Disabled Veteran Exclusion Requirements:** 

- Certification of Veteran's Property Tax Exclusion (For either the Veteran or Surviving Spouse)
- \_\_\_\_\_ Completed and signed application
