- A. Real Estate Description and Values. Real Estate is permanently listed, which means it is carried forward each year. We transfer ownership by Deed as of January 1 of each year. If property has been transferred by Will, you must provide our office with a copy of the document.
- **B.** Name and Mailing Address. Make corrections if information has changed.
- C. Personal Property: This includes,
 - Singlewide Mobile Homes by year, make, model, length and width; provide the complete serial number or identification number shown on the title.
 - Aircraft by year, make, model, serial number and registration number.
 - Boats by year, make, model, length and provide the hull ID number.
 - Boat motors by year, make and horsepower and indicate if inboard or outboard.
 - Jet Skis by year, make, model and provide the hull ID number.
 - Motor vehicles: you must list; UNLICENSED, IRP, APPORTIONED, PERMANENT OR 3 MONTH FARM TAGS including cars, trucks, motorcycles, camping trailers, motor homes, boat trailers, utility trailers, etc. Provide the name shown on the title, year, make, model, body style and complete Vehicle Identification Number (VIN). Without the VIN, we cannot accurately value the vehicle. Indicate the condition of vehicle as well.
 - DO NOT LIST VEHICLES WITH A CURRENT ANNUAL LICENSE TAG (WHICH YOU RENEW EVERY YEAR)

- **D.** If personal property is located on rented land, indicate the name of landlord or property owner.
- **E.** Indicate the physical address and/or mobile home park and lot number where the mobile home is located.
