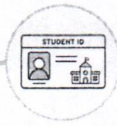

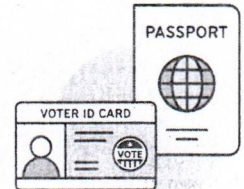
# Acceptable forms of Photo ID



The following IDs must be valid and unexpired or expired for one year or less:



- NC driver's license or state ID from the NCDMV ("non-operator ID")
- Driver's license or non-operator card from another state, D.C., or U.S. territory (*Voter must have registered in NC within 90 days of the election*)
- U.S. Passport book or U.S. Passport card
- NC voter photo ID card, issued by a county board of elections
- Student & government-employee photo IDs approved by the State Board of Elections<sup>1</sup> (*complete list on following page*)

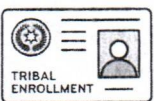
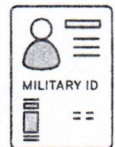


**NOTE:** Voters **65+** may use an expired form of acceptable ID if the ID was unexpired on their 65th birthday.



The following IDs are **not required to have an expiration date**. If such ID has an expiration date, the ID is an acceptable form of ID even if it is expired:

- Military or veterans photo ID card (with photo) issued by the US government
- ID card (with photo) issued by an agency of the US or NC government for a public assistance program
- Tribal enrollment card (with photo) issued by a tribe recognized by the State or federal government<sup>2</sup>

- Coharie Tribe
- Haliwa-Saponi Tribe
- Lumbee Tribe of North Carolina
- Meherrin Tribe
- Occaneechi-Saponi Tribe
- Sappony Tribe
- Waccamaw Siouan Tribe

<sup>1</sup> Once the State Board approves an institution's photo ID card, older photo IDs for that institution that remain in circulation are valid for voting, so long as the voter's ID is valid and unexpired. A photo ID card that has no expiration date is not expired.

<sup>2</sup> Tribes listed here are located in North Carolina, but enrollment cards from all federally recognized tribes are permitted. (All federally recognized tribes are listed in a separate document.)
